C) Qualifications and Experience for Teaching Staff for UG Teachers:

(Applicable for direct recruitment but age will be relaxed in case of Promotion)

i) ESSENTIAL:

- a) A degree in Ayurved from a University established by law or a statutory Board/ Faculty/Examining Body of Indian Medicine or its equivalent as recognized under Indian Medicine Central Council Act, 1970.
- b) A Post-graduate qualification in the subject/specialty concerned included in the schedule to Indian Medicine Central Council Act, 1970.

ii) EXPERIENCE:

- a) **For the Post of Professor:** Total teaching experience of **ten** years in concerned subject is necessary out of which there should be **five** years teaching experience as Reader/ Associate Professor in concerned subject.

b) **For the Post of Associate Professor (Reader):**

Teaching experience of **five** years in concerned subject. (Reader will be treated as Associate Professor).

c) **For the Post of Asst. Professor (Lecturer): (age not exceeding 40 years).**

No teaching experience is required. Lecturer will be treated as Assistant Professor.

d) **Qualification for the Post of Head of Institution (Principal/Dean/Director):**

The qualification and experience prescribed for the Post of Professor shall be essential for these posts.

NOTE : In absence of candidate of Post-graduate qualification in concerned subject the candidate of following subjects as mentioned against them shall be eligible for Lecturer/Asst. Professor :-

- a. The above provision of allied subject will be allowed for five years (The Gazette of India dated 26/04/2012).
- b. The Teacher(s) who had been considered eligible in the past on the basis of previous Regulations shall not be considered ineligible on the basis of amendment.
- c. For the Post of Lecturer in : M.A. in Sanskrit or Acharya from a in Sanskrit recognized institutions or equivalent with due experience. Preference should be given to those possessing Ayurved qualifications also.
